The volume also significantly contributes to our cross-linguistic knowledge, as it includes chapters with a focus on Blackfoot, Cantonese, Dagaare, English, Halkomelem, Lithuanian, Malagasy, Mandarin, Ojibwe, and Persian, as well as discussion of several other languages including Armenian, Hungarian, and Korean. The overall consensus of this volume is that while the general concepts of count and mass are available to all humans, forms of grammaticalization involving number, classifiers, and determiners play a key role in their linguistic treatment, and indeed in whether these concepts are grammatically expressed at all. This variation may be reflect the fact that count/mass is just one possible realization of a deeper and broader concept, itself related to the categories of nominal and verbal aspect.

Barbed Wire Diplomacy - Neville Wylie 2010-03-25
Barbed Wire Diplomacy examines how the United Kingdom government went about protecting the interests, lives and well-being of its prisoners of war (POWs) in Nazi Germany between 1939 and 1945. The comparatively good treatment of British prisoners in Germany has largely been explained by historians in terms of rational self-interest, reciprocity, and influence of Nazi racism, which accorded Anglo-Saxon servicemen a higher status

than other categories of POWs. By contrast, Neville Wylie offers a more nuanced picture of Anglo-German relations and the politics of prisoners of war. Drawing on British, German, United States and Swiss sources, he argues that German benevolence towards British POWs stemmed from London's success in working through neutral intermediaries, notably its protecting power (the United States and Switzerland) and the International Committee of the Red Cross, to promote German compliance with the 1929 Geneva convention, and building and sustaining a relationship with the German government that was capable of withstanding the corrosive effects of five years of warfare. Expanding our understanding of both the formulation and execution of POW policy in both capitals, the book sheds new light on the dynamics in inter-belligerent relations during the war. It suggests that while the Second World War should be rightly acknowledged as a conflict in which traditional constraints were routinely abandoned in the pursuit of political, strategic and ideological goals, in this important area of Anglo-German relations, customary international norms were both resilient and effective.

Furthermore, it is vital for Pakistan, and its relations with external aid donors, that it provides clear evidence that it will

DFID must likewise set measurable targets against which to measure and confirm positive impacts arising from effective investment in anti-corruption measures. In more detailed comments, the value delivered by the DFID Maternal and New-born Health Programme is acknowledged but scepticism is expressed about recent efforts to 'scale-up' at a provincial level. Closer to home, the Committee also calls on UK DFID to explore innovative ways to work more closely with the UK Pakistani diaspora, to improve their participation in monitoring DFID projects and, where appropriate, to align diaspora funding and remittance flows to Pakistan with DFID supported programmes.
