## *God's Eugenicist* - ANDRÉS HORACIO REGGIANI 2007

THE TEMPTATIONS OF A NEW GENETICALLY INFORMED EUGENICS AND OF A REVIVED FAITH-BASED, WORLD-WIDE POLITICAL STANCE, THIS STUDY OF THE INTERACTION OF SCIENCE, RELIGION, POLITICS AND THE CULTURE OF CELEBRITY IN TWENTIETH-CENTURY EUROPE AND AMERICA OFFERS A FASCINATING AND IMPORTANT CONTRIBUTION TO THE HISTORY OF THIS MOVEMENT. THE AUTHOR LOOKS AT THE CAREER OF FRENCH-BORN PHYSICIAN AND NOBEL PRIZE WINNER, ALEXIS CARREL (1873-1944), AS A WAY OF UNDERSTANDING THE POPULARIZATION OF EUGENICS THROUGH RELIGIOUS FAITH, SCIENTIFIC EXPERTISE, CULTURAL DESPAIR AND RIGHT-WING POLITICS IN THE 1930S AND 1940S. CARREL WAS AMONG THE MOST PRESTIGIOUS EXPERIMENTAL SURGEONS OF HIS TIME WHO ALSO HELD DEEPLY ILLIBERAL VIEWS. IN MAN, THE UNKNOWN (1935), HE ENDORSED FASCISM AND CALLED FOR THE ELIMINATION OF THE "UNFIT." THE BOOK BECAME A HUGE INTERNATIONAL SUCCESS, LARGELY THANKS TO ITS PROMOTION BY READERS' DIGEST AS WELL AS BY THE AUTHOR'S FRIENDSHIP WITH CHARLES LINDBERGH. IN 1941, HE WENT INTO THE SERVICE OF THE FRENCH PRO-GERMAN REGIME OF VICHY, WHICH APPOINTED HIM TO HEAD AN INSTITUTION OF EUGENICS RESEARCH. HIS INFLUENCE WAS REMARKABLE, AFFECTING RADICAL ISLAMIC GROUPS AS WELL LE PEN'S FRONT NATIONAL THAT CELEBRATED HIM AS THE "FOUNDER OF ECOLOGY."

## **FATHERS, FAMILIES, AND THE STATE IN FRANCE, 1914-1945** - KRISTEN STROMBERG CHILDERS 2003

THE STATE'S POLICY WITH REGARD TO FATHERS AND FATHERHOOD HAD A GREAT IMPACT ON CONCEPTS OF CITIZENSHIP AND GENDER IN FRANCE IN THE ERA OF THE TWO WORLD WARS. DRAWING ON NEW MATERIAL THAT HAS ONLY RECENTLY BECOME AVAILABLE FROM THE ARCHIVES OF THE VICHY REGIME, KRISTEN STROMBERG CHILDERS ANALYZES THE WAYS FATHERS WERE PROMOTED AS SAVIORS OF THE NATION AFTER FRANCE'S HUMILIATING DEFEAT BY THE GERMANS IN JUNE 1940. CHILDERS ARGUES THAT CONCERN FOR THE FAMILY AND FOR THE STATUS OF FATHERS IN MODERN FRANCE WAS NOT MERELY A RESPONSE TO FALLING BIRTHRATES AND GERMAN AGGRESSION, BUT WAS FUNDAMENTAL TO THE VERY NOTION OF CITIZENSHIP AND POLITICAL PARTICIPATION. THE DEBATE ON MEN AS GENDERED BEINGS, CHILDERS DEMONSTRATES, IS CENTRAL TO THE POLITICAL, SOCIAL, AND CULTURAL HISTORY OF FRANCE IN THE MODERN AGE. THE FATHER FIGURE BECAME A FOCUS AS PARTICIPANTS FROM ALL CLASSES AND ACROSS THE POLITICAL SPECTRUM DEBATED WHAT WAS WRONG WITH THE FRENCH FAMILY AND WHAT POLICIES WERE NEEDED TO REMEDY THE PROBLEM. CHILDERS EXAMINES HOW THESE POLICIES WERE IMPLEMENTED, WHAT THEY REVEAL ABOUT THE DEVELOPMENT OF THE WELFARE STATE IN FRANCE, AND HOW THEY HELP EXPLAIN THE IMPORTANCE OF VICHY IN TWENTIETH-CENTURY FRENCH HISTORY. TWENTY-EIGHT ILLUSTRATIONS, INCLUDING FIFTEEN PHOTOGRAPHS, MANY NEVER PREVIOUSLY PUBLISHED, COMPLEMENT HER ARGUMENT.

LIVING WITH HISTORY FOCUSES ON A PARTICULAR ASPECT OF HERITAGE PRESERVATION IN THE TWENTIETH CENTURY: DESTRUCTION AND POSTWAR RECONSTRUCTION IN BELGIUM, FRANCE, GERMANY, GREAT BRITAIN, AND THE NETHERLANDS. THIS BOOK ESTABLISHES A STATUS QUAECTIONIS FOR THE HISTORIOGRAPHY OF WARTIME AND POSTWAR PRESERVATION, AND SETS THESE PARTICULAR DEVELOPMENTS IN PRESERVATION HISTORY IN THE CONTEXT OF THE GENERAL EVOLUTION OF ARCHITECTURE AND URBANISM. THE AUTHORS INVESTIGATE THE SPECIFIC ROLE OF CONSERVATIONISTS AND HERITAGE INSTITUTIONS AND ADMINISTRATIONS IN THE OVERALL RECONSTRUCTION AND EXAMINE THE PART PLAYED BY ARCHITECTS AND PLANNERS IN HERITAGE PRESERVATION.

## **ASSASSINATION IN VICHY** - GAYLE K. BRUNELLE 2020

DURING THE NIGHT OF 25 JULY 1941, ASSASSINS PLANTED A TIME BOMB IN THE BED OF THE FORMER FRENCH INTERIOR MINISTER, MARX DORMOY. THE EXPLOSION ON THE FOLLOWING MORNING LAUNCHED A TWO-YEAR INVESTIGATION THAT TRACED DORMOY'S MURDER TO THE HIGHEST ECHELONS OF THE VICHY REGIME. DORMOY, WHO HAD LED A 1937 INVESTIGATION INTO THE "CAGOLE," A VIOLENT RIGHT-WING TERRORIST ORGANIZATION, WAS THE VICTIM OF A CAPTIVATING REVENGE PLOT. BASED ON THE METICULOUS EXAMINATION OF THOUSANDS OF DOCUMENTS, ASSASSINATION IN VICHY TELLS THE STORY OF DORMOY'S MURDER AND THE INVESTIGATION THAT FOLLOWED. AT THE HEART OF THIS BOOK LIES A TRUE CRIME THAT WAS SENSATIONAL IN ITS DAY. A MICROHISTORY THAT TELLS A LARGER AND MORE SIGNIFICANT STORY ABOUT THE DEVELOPMENT OF FAR-RIGHT POLITICAL MOVEMENTS, DOMESTIC TERRORISM, AND THE IMPORTANCE OF COURAGE, ASSASSINATION IN VICHY EXPLORES THE IMPACT OF FRANCE'S DEEP POLITICAL DIVISIONS, WARTIME CHOICES, AND POST-WAR MEMORY.

## *PÉTAIN'S JEWISH CHILDREN* DANIEL LEE 2014-06-05

PÉTAIN'S JEWISH CHILDREN EXAMINES THE NATURE OF THE RELATIONSHIP BETWEEN THE VICHY REGIME AND ITS JEWISH CITIZENS IN THE PERIOD 1940 TO 1942. PREVIOUS STUDIES HAVE GENERALLY VIEWED THE EXPERIENCES OF FRENCH JEWRY DURING THE SECOND WORLD WAR THROUGH THE LENSES OF PERSECUTION, RESISTANCE, OR RESCUE; AN APPROACH WHICH HAS HAD THE UNINTENDED EFFECT OF STRIPPING JEWISH ACTORS OF THEIR AGENCY. THIS VOLUME, HOWEVER, DRAWS ATTENTION TO THE SPECIFIC CATEGORY OF FRENCH JEWISH YOUTH WHICH REVEALS SIGNIFICANT EXCEPTIONS TO VICHY'S ANTISEMITIC POLICIES, WHEREIN THE REGIME'S DESIRE FOR A

REINVIGORATED YOUTH AND THE REBIRTH OF THE NATION TOOK PRECEDENCE OVER ITS RACIAL LAWS. WHILE JEWS WERE BECOMING MARGINALISED FROM THE CIVIL SERVICE AND LIBERAL PROFESSIONS, THE NEW ORDER DID NOT SEEK TO EXCLUDE YOUNG FRENCH JEWS FROM PARTICIPATING IN A SERIES OF YOUTH PROJECTS THAT AIMED TO REBUILD FRANCE IN THE AFTERMATH OF ITS DEFEAT TO GERMANY. FOR EXAMPLE, THE JEWISH SCOUTS' EMPHASIS ON MANUAL WORK AND A RETURN TO THE LAND ENSURED THAT IT WAS LOOKED UPON FAVOURABLY BY VICHY, WHO REWARDED THE SCOUTS FINANCIALLY. SIMILARLY, YOUNG FRENCH JEWS WERE CALLED UP TO TAKE PART IN THE CHANTIERS DE LA JEUNESSE, VICHY'S ALTERNATIVE TO COMPULSORY MILITARY SERVICE. IN CONSIDERING THE ROLES OF SOME OF VICHY'S LESSER KNOWN MINISTERS WITH RESPONSIBILITIES FOR YOUTH, FOR WHOM ANTISEMITISM WAS NOT A PRIORITY, PAIN'S JEWISH CHILDREN ILLUMINATES THE TENSIONS BETWEEN VICHY'S AMBITION FOR NATIONAL REGENERATION AND ITS RACIAL POLICIES, RENDERING ANY SIMPLE ACCOUNT OF ITS ANTISEMITISM MISLEADING. WHILE HINDSIGHT MAY POINT TO THE CONTRARY, THIS VOLUME SHOWS THAT THE EMERGENCE OF THE NEW REGIME DID NOT SIGNAL THE BEGINNING OF THE END FOR FRENCH JEWRY. IN VICHY'S FIRST TWO YEARS, WHILE AMBIGUITY REIGNED, POSSIBILITIES TO INTEGRATE AND PARTICIPATE WITH THE NEW ORDER ENDURED AND JEWS WERE CONSTANTLY PRESENTED WITH NEW AVENUES TO PROBE AND EXPLORE. AFTER THIS POINT, THE DRASTIC POLICY CHANGES FUELLED BY PRIME MINISTER PIERRE LAVAL AND THE HEAD OF VICHY POLICE, RENÉ BOUSQUET, COUPLED WITH THE TOTAL OCCUPATION OF FRANCE BY GERMAN FORCES IN NOVEMBER 1942, REDUCED THE POSSIBILITIES FOR COEXISTENCE ALMOST TO NOTHING.

CATHOLICISM AND THE WELFARE STATE IN SECULAR FRANCE - FABIO BOLZONAR 2023-10-02

EVEN THOUGH THE POLICY IMPACT OF CATHOLICISM HAS INCREASINGLY BEEN ACKNOWLEDGED, EXISTING SCHOLARSHIP LACKS A COHERENT VIEW ON ITS CHANGING INFLUENCE OVER TIME AND IN DIFFERENT POLITICAL CONTEXTS. IN THIS BOOK, FABIO BOLZONAR INVESTIGATES THE INFLUENCE OF CATHOLICISM ON DEVELOPMENTS IN FRENCH SOCIAL PROTECTION FROM WORLD WAR II TO THE MID-2010S. HE DISCUSSES THE FACTORS THAT HAVE FAVOURED OR INHIBITED IT AND EXPLORES THE HYBRIDIZATION BETWEEN CATHOLIC VALUES AND SECULAR PRINCIPLES IN THE SOCIAL ENGAGEMENT OF CATHOLIC ACTORS IN SECULAR FRANCE. BY DOING SO, THIS MULTIDISCIPLINARY STUDY INTEGRATES CURRENT SCHOLARSHIP, WHICH HAS GIVEN LIMITED ATTENTION TO THE CHANGING PATTERNS OF CATHOLIC INVOLVEMENT IN THE SOCIAL POLICY DOMAIN OVER A LONG PERIOD OF TIME, AND THE RENEWED INFLUENCE OF CATHOLIC VALUES IN SECULARIZED SOCIETIES. CATHOLIC MOBILIZATION HAS RELOCATED FROM THE POLITICAL TO THE CIVIL SOCIETY SPHERE, MAKING VOLUNTARY ORGANIZATIONS AND SOCIAL MOVEMENTS, RATHER THAN POLITICAL PARTIES, THE MAIN CHANNELS FOR DEFENDING CATHOLIC VALUES IN SECULAR FRANCE. RATHER THAN MARGINALIZING CATHOLICISM, THIS PROCESS HAS OPENED UP NEW OPPORTUNITIES FOR CATHOLIC ACTORS AND VALUES TO PLAY A SIGNIFICANT ROLE IN SOCIETY AND POLITICS. BOLZONAR IDENTIFIES TWO DIVERGENT SCENARIOS THAT DEFINE CATHOLIC SOCIAL ENGAGEMENT IN CONTEMPORARY FRANCE: EITHER THE STRENGTHENING OF NEW FORMS OF INSTITUTIONAL COLLABORATION BETWEEN CATHOLIC-INSPIRED PHILANTHROPIC ORGANIZATIONS AND PUBLIC ADMINISTRATIONS IN THE INTEREST OF SOCIALLY VULNERABLE CITIZENS, OR THE EMERGENCE OF NEW IDEOLOGICAL CONFLICTS ON GENDER- AND SEXUALITY-RELATED ISSUES.

THE WAR GUILT PROBLEM AND THE LIGUE DES DROITS DE L'HOMME IS A SIGNIFICANT NEW VOLUME FROM NORMAN INGRAM, ADDRESSING THE HISTORY OF THE LIGUE DES DROITS DE L'HOMME (LDH), AN ORGANISATION FOUNDED IN 1898 AT THE HEIGHT OF THE DREYFUS AFFAIR AND WHICH LAY AT THE VERY CENTRE OF FRENCH REPUBLICAN POLITICS IN THE ERA OF THE TWO WORLD WARS. INGRAM POSITS THAT THE LIGUE'S INABILITY TO RESOLVE THE QUESTION OF WAR GUILT FROM THE GREAT WAR WAS WHAT LED TO ITS DECLINE BY 1937, WELL BEFORE THE NAZI INVASION OF MAY 1940. AS WELL AS DEVELOPING OUR UNDERSTANDING OF HOW THE ISSUE OF WAR ORIGINS AND WAR GUILT TRANSFIXED THE LDH FROM 1914 DOWN TO THE SECOND WORLD WAR, THIS VOLUME ALSO EXPLORES THE BIOLOGY OF FRENCH PACIFISM, EXPANDING ON THE DIFFERENCES BETWEEN FRENCH AND ANGLO-AMERICAN PACIFISM. IT ARGUES THAT FROM 1916 ONWARDS, ONE CAN SEE A PRINCIPLED DISSENT FROM THE UNION SACRÉE WAR EFFORT THAT OCCURRED WITHIN MAINSTREAM FRENCH REPUBLICANISM AND NOT ON THE SYNDICALIST OR ANARCHIST FRINGES. BASED ON SUBSTANTIAL RESEARCH IN A LARGE NUMBER OF FRENCH ARCHIVES, PRIMARILY IN THE PAPERS OF THE LDH WHICH WERE REPATRIATED TO FRANCE FROM THE FORMER SOVIET UNION IN LATE 2001, BUT ALSO ON CONSIDERABLE NEW RESEARCH IN THE GERMAN ARCHIVES, THE BOOK PROPOSES A NEW EXPLANATORY MODEL TO HELP US UNDERSTAND SOME OF THE CHOICES MADE IN VICHY FRANCE, MOVING BEYOND THE USUAL TRIPTYCH OF COLLABORATION, RESISTANCE OR ACCOMMODATION.
